#### Please describe the work

#### Response

The Scottish Government has tasked the Care Inspectorate with providing scrutiny and assurance of justice social work. Between 2018 and 2021 our focus was on the inspection of community payback orders delivered by justice social work services, however, as a consequence of the Covid-19 Pandemic, and other emerging priorities, this workstream was suspended in favour of a broader, thematic approach. The time is now right to renew our focus on the delivery of community sentences by local authority justice services, informed by the current national aims and objectives for justice within the <a href="Mattended-Institute of Strategy">National Strategy</a>.

Aim 2 of the National Strategy for Community Justice is to "Ensure that robust and high-quality community interventions and public protection arrangements are consistently available across Scotland".

In relation to community sentences, there is an associated priority action to "Ensure that those given community sentences are supervised and supported appropriately to protect the public, promote desistence from offending and enable rehabilitation by delivering high quality, consistently available, trauma-informed services and programmes." (Priority Action 5).

Key to delivering this priority, and the overarching aim, is the ability of justice social work services to demonstrate that the supervision and support offered to those on community sentences is of a high quality. Given the current pressures on the prison estate, there is also a clear need to build confidence in the quality, efficiency and effectiveness of community sentences.

Learning from our previous scrutiny work across justice social work services highlighted that performance management and quality assurance were key areas for improvement. We found that in general there was no consistency in the format of performance frameworks, the type of measures or frequency of reporting. Some services had yet to clearly define a range of strategic priorities for the justice service or fully embed approaches to measuring performance. Accessing timely and reliable data to aid analysis of performance was often challenging as information management systems could be difficult to interrogate.

We also found that services were often limited in their ability to demonstrate the difference that CPO's were making. Most areas had yet to agree a set of identified, person-centric outcomes against which progress or change could be demonstrated. This was exacerbated by an absence of consistent data or standardised mechanisms to capture the necessary information. Services were not consistently gathering feedback from people using their service or stakeholders

The sector is facing significant demands for change, innovation and improved efficiency. As such, there is an urgent need for leaders and managers at all levels to demonstrate the quality and effectiveness of current practice to build public and stakeholder confidence in the effectiveness of community-based sentencing

This review will focus on the current capacity of services to evidence performance, quality and outcomes in relation to community based sentences. The review will not focus directly on the effectiveness of community interventions - instead it will focus on the sector's ability to confidently evidence the effectiveness of community support and supervision.

The review will be informed by Quality Indicator 6.4 (Performance Management and Quality Assurance) which is drawn from the Care Inspectorate's *Quide to Self-Evaluation for Community Justice in Scotland*. The aim is to develop a clear understanding of strengths and develop an evidence-base that informs local and national improvement initiatives

By using a self-evaluation approach rather than a traditional inspection model, we hope to minimise the burden on local authorities whilst building capacity for improvement across the sector.

The proposal is to undertake the review in three phases:

#### § Phase 1: National Self-Evaluation – September to November 2024

All local authorities will be supported to undertake a proportionate self-evaluation against Quality Indicator 6.4: Performance Management and Quality Assurance, using a specially developed tool.

The Care Inspectorate team will analyse the responses to identify confidence levels across the sector. We will also identify key strengths and challenges emerging from the evaluations.

§ Phase 2 – Validation Activity – February to March 2024
The Care Inspectorate team will select up to five local authority areas for additional activities to validate the self-evaluation. This will include review of documentary evidence and focus groups with staff and people who use services.

Participating local authorities will receive a validation letter and feedback on their self-evaluation.

#### § Phase 3 - Reporting - May 2024

A final thematic report will be prepared summarising the findings of the national self-evaluation and the key messages emerging from the validation activity. This will reflect national messages - findings will not be attributed to individual local authorities.
