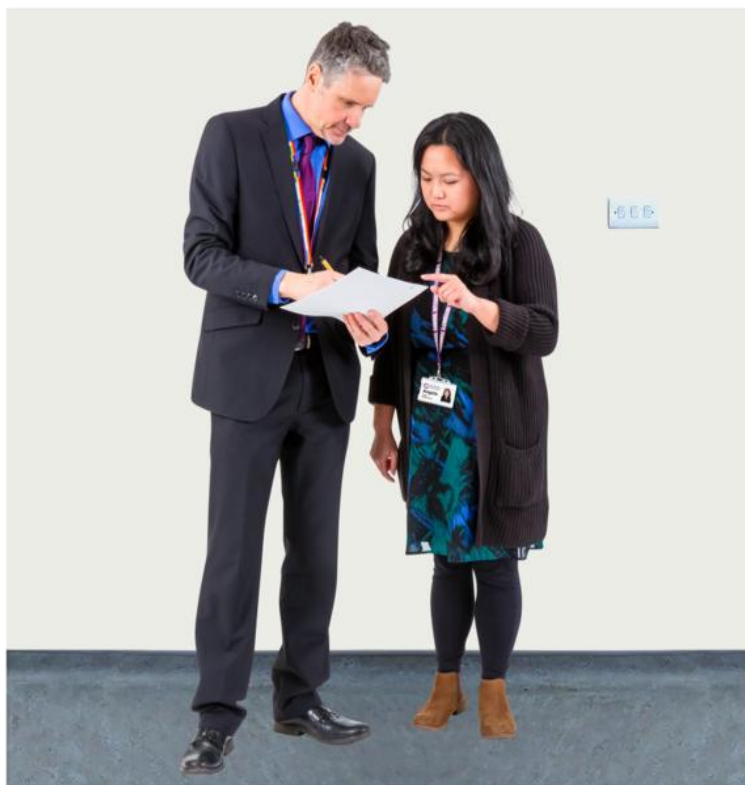


Information about joint inspection of services for children and young people subject to Compulsory Supervision Orders living at home with their parents

This information is from the Care Inspectorate.

The Care Inspectorate looks at social work and social care services in Scotland to see how good they are.



We work with Healthcare Improvement Scotland.

They look at healthcare services in Scotland to see how good they are.



We work with His Majesty's Inspectorate of Constabulary in Scotland.

They look at police services in Scotland to see how good they are.



We work work with His Majesty's Inspectorate of Education in Scotland.

They look at education services in Scotland to see how good they are.



Sometimes we all work together to look at services in a local area. This is called a **joint inspection**.

A **joint inspection** finds out how good services are when they work together to help people.

We do joint inspections to help make services better.



A **Compulsory Supervision Order** is a **legal** document.

Legal means the law says people must do what the document says

A **Compulsory Supervision Order** is made at a **Children's Hearing**.



Meeting

A **Children's Hearing** is a legal meeting about what needs to happen to make sure a child is safe and can grow and develop.

Parents and children can attend this meeting.



When a **Compulsory Supervision Order** is made a **Social Worker** will visit the child regularly.

A **Social Worker** will visit to make sure the child has the love and care and help they need.

What our joint inspection is about

Our **joint inspection** helps us find out how local services help children who have a **Compulsory Supervision Order** and live at home with their parents.



We want to make sure that children get the right help to grow and develop and be safe.



How we will do this

Inspectors will visit your local area.

Inspectors are people who will do the **joint inspection**.



Inspectors will read information about how local services help children who have a **Compulsory Supervision Order** and live at home with their parents.



Inspectors will visit local services who help children and speak to staff.

Inspectors will speak to children who have a **Compulsory Supervision Order** and live at home with their parents.

	<p>The inspectors will also speak to the children's parents.</p> <p>The inspectors want to find out about what children and parents think of services.</p>
 <p>You</p>	<p>Who can be involved</p> <p>You can be involved if you are a parent of a child who has a Compulsory Supervision Order and lives at home with you some or all of the time.</p>
<p>Tell us what you think</p> 	<p>How you can get involved</p> <p>You can tell us about how good services are at working together to help your child grow and develop and be safe.</p>
	<p>You can do this by speaking to an Inspector.</p> <p>You can meet with them in person or speak to them by phone.</p>

	<p>What happens after a joint inspection?</p> <p>We will write a report about what local services are doing well.</p> <p>We also write in our report about what local services need to improve.</p>
	<p>We will put this report on our website to tell everyone about what we found out.</p>
	<p>We will ask local services to work together to make a plan.</p>



This plan will be about how they will improve the help they give to children who have a **Compulsory Supervision Order** and live at home with their parents.



More information you might need

If you are not getting the right help from a local service.

You can complain about a service in your local area.

To do this, contact your local council.
They will tell you how to complain or who to speak to.
