1.0 BACKGROUND

The Care Inspectorate's Board approved the current Reservation of Powers and Scheme of Delegation and Standing Orders on 27 June 2014. The Reservation of Powers and Scheme of Delegation incorporates amendments proposed by Committees or the Board

2.0 CONSULTATION

Consultation has principally been by way of Committee (and Board) effectiveness sessions, ensuring that all Board members have had the opportunity to contribute to discussion of the changes proposed.

3.0 PROPOSED AMENDMENTS

- 3.1 The proposed amendments are incorporated as tracked changes in Appendices 1 and 2. It is not proposed to discuss each change individually. They are designed to give effect to the changes proposed by Committees in the 2015 Committee Effectiveness sessions. The minutes of the Committee Effectiveness sessions held in January / February 2015 are attached as Appendices 3-6
- 3.2 The attached amended Reservation of Powers and Scheme of Delegation does not seek to formally introduce specific reference to Environment and Sustainability into the Resources Committee Terms of Reference, on the basis that these matters are the subject of statutory duties, and while the Care Inspectorate is committed to fulfilling all of its statutory duties and recognises the importance of those relating to climate change, sustainability and the environment, the Terms of Reference of its committees would become extremely cumbersome if all relevant statutory duties upon the Care Inspectorate were specifically reflected therein.
